

Monthly Meat Production (million lbs)






Direct-to-Consumer Supply Chains

Supply chain configurations (2015 market shares)

- On-farm stores (44%)
- Farmers' markets (23%)
- Roadside stands (8%)
- CSAs (7%)
- Online (6%)
- Other (12%)

- Labeling






Little Margin for Error

Relatively stable food supply chains prior to Covid-19 led to ...

- Optimized supply chains with minimal inventory
- Close matching of incoming demand and outgoing supply
- Stable buyer-seller relationships
- Optimized truck fleets with minimal excess capacity






What can be done now to improve food supply chain resilience?

Guidance from recent research

Multilayer Network Model

- Captures product and service flows across sectors and locations
- Currently 41 sectors and 115 locations
- Models the propagation of supply and demand shocks along supply chains
 - Shock propagates from a source node to other nodes by reducing supply and demand flows to other nodes



Preliminary Network Model Results

Fragility Risk of Selected Sectors

- Fragility Level:
 The possibility of a small failure at one node leading to a large avalanche of failed nodes
- Fragility Risk:

 Interaction between
 fragility level of a node
 and its exposure to
 supply and demand
 shocks

Implications of Network Model Results

For businesses

- More supply chain partners, and more geographically diverse partners
- More flexibility to shift between grocery and foodservice markets
- Maintain larger inventories
- Reduce exposure to shocks at each node of the supply chain
- Stress tests of supply chain resilience

For governments

- Financial support to develop and pilot-test supply chain initiatives that increase resilience
- Regulatory flexibility during crises to facilitate shifts between grocery and foodservice


