

# POWERPOINT SLIDES

**PowerPoint slides:** These slides are provided in both English and Spanish. In the NOTES view, you will find a script to go along with each slide, also provided in English and Spanish. The entire presentation, as scripted, will take approximately 30-40 minutes. These slides were developed cooperatively by the agriculture health and safety centers funded by the National Institute for Occupational Safety and Health (NIOSH), which is a part of the CDC, so these slides have been approved by CDC/NIOSH. This particular slide set has been adapted to include photos more in keeping with the Southeast's diverse workforce. 
